Dear Department of Justice,

Working It Out (WIO) has prepared this feedback on the Tasmanian Department of Justice's proposed Family Violence (Miscellaneous Reforms) Bill 2025. As Tasmania's sole dedicated support, advocacy, and education service for the lesbian, gay, bisexual, transgender, intersex, queer, and asexual (LGBTIQA+) community, WIO is committed to fostering change through education grounded in lived experience. Our goal is to empower LGBTIQA+ Tasmanians to lead fulfilling lives.

We appreciate the opportunity to <u>provide feedback</u> on the *Family Violence* (*Miscellaneous Reforms*) *Bill 2025*. WIO is supportive of efforts to strengthening protections for victim-survivors of family violence and recommend the following to ensure implementation of the bill is fit-for-purpose regarding the unique experiences and needs of LGBTIQA+ people, who face distinct forms of abuse and systemic barriers to support and are at risk of misidentification by the systems.

Key Recommendations

1. Recognition of LGBTIQA+ Family Violence Dynamics:

• Ensure comprehensive understanding and response to LGBTIQA+ family violence across justice, policing, and support service systems.

2. Mandatory Cultural Competency Training:

- Require LGBTIQA+ cultural competency training and adequate resourcing for all
 professionals in the family violence response system—including police, courts, and
 support services. This will:
 - 1. Safeguard LGBTIQA+ victim-survivors
 - 2. Support appropriate responses to suspected or actual perpetrators
 - 3. Help prevent family violence within LGBTIQA+ communities

Supporting Evidence

Insights from RACGP Guidelines on LGBTIQA+ Family Abuse and Violence (2022):

- LGBTIQA+ people experience family violence more frequently than non-LGBTIQA+ Australians, including intimate partner abuse and violence from families of origin
- Intersectional risk factors for those with multiple marginalised identities.
- Health disparities linked to discrimination and abuse.
- Elevated suicide risk due to family rejection and trauma.
- Barriers to help-seeking due to heteronormative service models.

Barriers identified in Engender Equality's LGBTIQA+ Family Violence Guidelines (2024):

- Heteronormative framing excludes or minimises LGBTIQA+ experiences.
- Fear of exclusion from mainstream services.
- Pressure to appear "healthy" to avoid reinforcing stereotypes about LGBTIQA+ relationships.
- Victims may hesitate to report violence due to concern for the abuser or local community standing.
- Reporting abuse may force individuals to reveal both their experience of violence and their LGBTIQA+ identity.
- Distrust of police, with over half of Australian LGBTIQA+ survivors feeling unsupported by police.
- Misidentification of abuse due to lack of tools to identify the primary aggressor.
